The concept of cultural accessibility

The right of access to culture is enshrined in the Universal Declaration of Human Rights (article 27, 1948) and in the United Nations on the Rights of Persons with Disabilities (article 30, 2006).

Cultural accessibility is the conceptual tool for implementing this right, avoiding the perpetuation and creation of discriminations, as well as physical, sensory, mental, psychological, cognitive, social, financial and cultural barriers.

Cultural accessibility covers access to media, works of art, cultural heritage, digital content, as well as arts and cultural practices, amateur and professional.

The concept applies to cultural venues and all outreach work, including places in which people with a disability live.

Its implementation requires policies and action plans which dynamically and collaboratively involve all local stakeholders.

The concept of cultural accessibility generates research, knowledge, skills and new professions in the cultural sector.
